Fees are registration fee of \$100.00 and a match fee of \$150 for each ISSF event and \$80 for each non ISSF event. Mixed team event cost will be split in half for each athlete at \$40 each.

3 person team registration will be available on site for a cash fee of \$20.00 per team.

Protest fees are \$50 per protest, must be payable to start protest procedure, along with an official Protest Form. Protest Forms are available on the ISSF Website. Funds are returned if ruled in favor of the protestor.

## **VISITORS AUTHORIZATION TO TRANSPORT PERMITS**

Competitors who are not residents of Canada are required to obtain an authorization to transport permit for their firearms, to enter and travel inside Canada. For additional information on Visitors to Canada please see the RCMP website at: <https://www.rcmp-grc.gc.ca/en/firearms/non-residents>, including information about 'Non-Resident Firearm

Declaration (Form RCMP 5589) which is required to bring firearms into Canada (velocity greater than 500 feet per second).

You will be required to provide your point of entry in Canada, arrival date, departure date and your expected residential address during your stay. The following information will be needed for each firearm: caliber, barrel length, serial number, and magazine or cylinder capacities, as applicable.

The following website will provide the necessary information concerning need for a Non-resident Firearms Declaration <http://www.rcmp.gc.ca/cfp> Please note: If there are difficulties, this process could take some additional time, so do not delay your application.

SFC will issue letters of invitation to international competitors only after the individual has successfully fully registered for the event and submitted a request for a letter by email to [members@sfc-ftc.ca](mailto:members@sfc-ftc.ca).

All requests should include travel dates, firearm details and the participant (and if applicable parent/guardian) full name, and home address.

### **CHECK-IN**

All athletes will need to check in upon arrival, before being allowed onto the range. Check-in is at the Saskatoon Wildlife Federation Range. Initial equipment control will be available at the same location.

### **RULES & EQUIPMENT**

All shooting events in this competition are registered with the Shooting Federation of Canada (SFC).

The ISSF Rules, effective January 1<sup>st</sup>, 2026, will be in effect except for the following exemptions:

A. Rifle Equipment Standards and Verification – Rule 7.5.2.1 and Rule 6.7.6.2 – shooting clothing will be held to the standard of the rules in effect before Dec 31<sup>st</sup>, 2025. SFC will make every effort to provide equipment for testing to allow opportunities for athletes to test equipment against new standards. Due to the challenges with testing, fees for subsequent testing will be waived.

B. Pistol Equipment – Rule 8.4.1.6 f) and 8.4.1.6 f) – Pistol grips will be held to the standard of the rules in effect before Dec 31<sup>st</sup>, 2025. SFC will make every effort to provide equipment for testing to allow opportunities for athletes to test equipment against new standards. Due to the challenges with testing, fees for subsequent testing will be waived.

C, Finals Timing – At the date of printing the availability of updates to technology to allow finals to run on revised timing is unknown. A decision will be made and communicated through the SFC website by June 15<sup>th</sup>. In the absence of new technology, the rules in effect before January 1<sup>st</sup>, 2026, will remain in effect.

**UPDATED June 13, 2026 – Technology updates have successfully taken place, and finals will run under 2026 ISSF Rules.**

The match committee reserves the right to modify the rules, procedures and times dependent upon range conditions and local circumstances. It is the responsibility of the athlete and coaches to be familiar with the ISSF rules. All equipment MUST meet the ISSF specifications. Although equipment check is optional, random spot checks will be performed on each relay. Shooting Mats for the live fire Rifle events will be available on site.

### **MATCH START TIMES**

Please note that the times on the schedule are the times for the first scoring shot in ISSF events (pursuant to Rule 7.9). Call to the line, preparation and sighting time will commence prior to the published start time. Due to any unforeseen circumstances, scheduling may vary. We strive to maintain the events on the days scheduled but times may be adjusted due to registration numbers and any other circumstances.

### **AIR RIFLE/PISOL PROPELLANT**

Compressed air will be available for filling of rifle and pistol cylinders, but competitors must provide their own tank/cylinder adapters. If you require CO2 gas, you must provide your own.

### **START LISTS**

Preliminary Squadding Sheets for the competition may be viewed on the SFC website through the National Championships event page after Aug 6<sup>th</sup>, 2026. Final Squadding will be posted at the Range. While we strive to have the initial Start List posted a few days prior to the competition, please be aware that Start Lists are subject to change, so double-check your assignment on the day of the match. It is the Athlete's responsibility to check the start lists for their events and know where they are scheduled to compete. PET will be assigned the same firing point as the first match of that event.

During the competition viewers can log onto [Megalink Live](#) and watch the event in real time. One range will be AHA and the other is Sask TSA.

### **COURSES OF FIRE**

PET: Will be squadded to Match 1 of the same event.

### **Match Relays**

#### **Pistol**

Due to range restrictions, some events have been restricted by gender and number of competitors. Thank you for your understanding.

**Centre Fire** – There will be a maximum of 14 competitors for this event and 1 relay, no final.

1. Fired on the 25 m range using electronic targets.
2. Call to the line before start time, sighting series. 60 competition shots per competition divided into 30 precision and 30 rapid fire.
3. In compliance with rule: 8.7.6.4 sub 5 all competitors will complete the precision stage before the rapid fire stage commences.
4. This is a gender open competition and SFC classes will be used.

**Militay Rapid** – There will be a maximum of 14 competitors for this event.

1. Fired on the 25 m range, using electronic targets.
2. Call to the line before start time, 250 seconds sighting series, 60 competition shots per competition.
3. This is a gender open competition and SFC classes will be used.
4. Each competitor will fire one complete course of fire in one day. No finals.

**25m Standard Pistol** – There will be a maximum of 28 competitors for this event and 1 relay per day of assigned shooting.

1. Fired on the 25 m range, using electronic targets.
2. Call to the line before start time, 250 seconds sighting series, 60 competition shots per competition.
3. This is a gender open competition and SFC classes will be used.
4. Each competitor will fire one complete course of fire in one day. No finals.

**25m Pistol (Women/AWAD Only)** – There will be a maximum of 28 competitors and is comprised of 1 relay per day of assigned shooting, repeated a second day, followed by Finals.

1. Fired on the 25 m range using electronic targets
2. Each competitor will fire two complete matches over two days.
3. Call to the line before start time, sighters, 60 competition shots per competition.
4. In compliance with rule: 8.7.6.4 sub 5 all competitors will complete the precision stage before the rapid-fire stage commences.

**25m Rapid Fire Men only** – There will be 3 competitors per relay over 1 day of assigned shooting with a maximum of 12 total competitors. Registration precedence will be given to men vying for SFC High Performance teams.

1. Fired on the 25 m range using electronic scoring.

2. Call to the line before start time, 8 seconds sighting series, 60 competition shots per competition to be completed in two halves of 30 shots per half course. Timing per half course is 8, 6, 4 seconds.

3. Each competitor will fire two complete matches over two days.

**10 m Air Pistol** - 1 relay per day of assigned shooting.

1. Competition takes place on the 10 m range using electronic targets.

2. Call to the line before start time, 15 minutes sighting and preparation, 60 competition shots for all competitors.

3. Competition is open to male, female and junior competitors, who will fire two complete matches over two days.

4. Sighting shots allowed in the time period assigned.

5. Finals

**10 m Mixed Teams Air Pistol** - 1 relay of assigned shooting.

1. Competition takes place on the 10 m range, using electronic targets.

2. Call to the line before start time, sighting/preparation and 30 competition shots for each competitor of a two person team. Scores added together to comprise final score

3. Competition is open to male, female and junior competitors but team must be comprised of one male and one female.

4. Competitors will fire one complete match over one day. No Final.

5. Sighting shots allowed in the time period assigned

**50m Pistol** – There will be a maximum of 15 competitors and 1 relay. 1. Fired on the 50 m range using electronic targets.

2. Call to the line before start time, sighting and preparation, followed by 60 shots in 1.5 hour time limit.

3. Each competitor will fire one complete match over one day.

4. Sighting shots allowed in the time period assigned.

5. No more than 60 record shots in the competition. No Final.

## **Rifle**

**Sporting Rifle & Hunting Rifle** - Sporting rifle will be shot on electronic targets, maximum 14 competitors, Hunting rifle will be shot on paper targets - 4 counting scoring diagrams per target, 5 shots per scoring diagram. Prone – 2 courses of 60 shots per course = 120 Maximum 18 competitors max. No final.

**ISSF Air Rifle 10 meters** - Standing (except Adaptive Shooting) – shot on electric targets. All competitors – 2 courses of 60 shots per course. Adaptive Shooting – 2 courses of 60 shots: 1 prone, 1 standing. Final.

**ISSF 3 Position** – Maximum 28 competitors. Unlimited sighting shots on sighting diagrams. Shot on electronic targets. Squadding for relays will be random. Men and Women 3 Position are fired simultaneously. Adaptive shooters will compete in their appropriate class (SH1 or SH2). 2 courses of 20 shots per each of 3 positions = 120. Final.

**ISSF Prone** – Maximum 14 competitors. Unlimited sighting shots on sighting diagrams. Shot on electronic targets. Adaptive shooters will compete in their appropriate class (SH1 or SH2). 2 courses of 60 shots per course = 120. No Final.

### **TEAM EVENTS, NO FINAL**

**ISSF Mixed Teams Air Rifle 10 meters** standing – shot on electronic targets. Each team competitor – 1 course of 30 shots per course, each team member’s score to be added together for total final score. Two-person team to be comprised of one male and one female. Air Rifle squadding will be assigned and posted at the range in advance of competition.

**Match Finals** : ISSF Format, for Open Category only. International athletes are not eligible for finals. Only Canadian citizens and/or Permanent Residents are eligible to shoot finals in the appropriate events. Final elimination will be based off selection procedures. Two day aggregate qualification scores added to make finals score, elimination is during finals, where applicable.

### **AWARD CATEGORIES**

Matches that have Open finals will have Champions awarded based off finals results.

Classification medals will be awarded when there are at least 3 competitors in that classification. If there are not 3 competitors in that classification, the competitor will be added into the next higher classification.

### **Classification**

Shooting Federation of Canada (SFC) members with a current, valid classification will compete in their respective class. Athletes that do not have a class will be placed in the Temporary Expert class for Sporting Rifle and all non-ISSF events and as a Temporary Master for all ISSF events, until a classification is achieved.

Adaptive Air Rifle: SH1 & SH2

Adaptive Air Pistol: SH1

Veteran – Veteran Class is for competitors who are 55 years or older as of January 1, 2026. Those competitors who have the age qualification may register in the Veterans class or in their regular class, but not both, and will shoot in all events either as a veteran or in their regular class.

Valid classes include: Master, Expert, Sharpshooter, Marksmen, Veteran, International Junior, Junior, Sub-junior, and AWAD classes as declared valid by the SFC. All classes male and female are considered valid.

Athletes can provide proof of classification if it varies from what is listed on the SFC website. After fully registering and completing the signature cards, the classification level submitted by the competitor will stand unless the Match Jury deems a change is required. If a competitor knowingly registers in a class that is below their actual class and does not take steps to rectify the issue, the competitor will be \$20 for falsification of documents.

### **SAFETY**

All pertinent firearms safety practices will be observed. Failure to follow safety rules or direction from Range Officers or Range Jury may be cause for disqualification and/or removal. Eye protection is recommended for all competitors and officials on ranges while shooting is in progress. Any medical emergencies should be immediately reported to a range official. The Organizing Committee and the Shooting Federation of Canada will not be responsible for any articles lost or stolen or any article left at the range during the competition. No uncased rifle or pistol firearms or air guns may be transported outside of the shooting range.

### **DRESS CODE**

All competitors, officials, coaches, volunteers and any other parties involved in this event must adhere to the ISSF Dress Code policy. If this policy is violated in any way, please immediately make a formal report of such breach to the Match Director, the Chief Range Officer and/or the relevant Section Chair.

### **WAIVER/ASSUMPTION OF RISK**

All adult participants must complete a waiver and the parents/guardians of minors will be required to complete and submit prior to competition, included in online registration. (Copy of forms in Appendix)

### **SFC CODE OF CONDUCT**

All competitors, coaches, officials, volunteers and any other parties involved in this event must adhere to the SFC Code of Conduct and Ethics.

SFC contracts with ITP Sport to act as the Independent Third Party for shooting in Canada should any concerns arise. Please see the Safe Sport page on the SFC website for more information.

### **OFFICIATING**

Juries will be appointed and convened as required to resolve any protest. The jury will resolve any scoring challenges. Decisions of the jury are final. This event is also being used to grow our officials in Canada. Please be patient and understanding as some may be gaining experience in newer rules.

**Special Notice of withdrawal given to athletes to withdraw from competition as authorized by Match Committee:**

In the event that a competitor's fired shot(s) hit the electronic scoring target protection plate, the following penalty sequence shall be followed:

First occurrence: YELLOW Card..... warning issued

Second occurrence: GREEN Card ..... 2 point penalty assigned

Third occurrence: RED Card ..... disqualification due to unsafe shooting. The score that has been fired for record will be entered into the record sheets. No refund will be offered to the competitor.

### **SMOKING**

Smoking or vaping is not permitted in any range, stats or scoring offices, any other closed room or tent, OR on any of the firing lines. Kindly go to designated smoking areas if required. Alcoholic beverages, cannabis use of any kind and/or any illegal substance use is not permitted on the premises at all.

### **ANTI-DOPING CONTROLS**

Anti-doping controls may be conducted by the Canadian Centre for Drug-free Sport in accordance with ISSF and International Olympic Committee anti-doping regulations.

### **NATIONAL TEAMS**

The criteria for any SFC team can be found on the Shooting Federation of Canada website.

### **COMPETITION RESULTS**

Results will be posted at the range upon completion of each match. Entire Championship results will be posted to the SFC website as soon as can be made possible.

## Appendix A

### **PARTICIPANT WAIVER – AGE OF MAJORITY**



#### **Canadian National Championships**

#### **2026 Event Rifle & Pistol**

#### **PARTICIPATION WAIVER**

**This waiver is to be completed by and is only for the use of those participants and spectators who have reached and/or are over the age of majority and should be completed and signed prior to any payment and/or registration or facility entry for this Event.**

I am aware that the 2026 Canadian National Rifle & Pistol Championships (the “Event”) involves many inherent risks, dangers and hazards, including but not limited to the use and operation of firearms, personal physical injury in association with target shooting as a sport, possible negligence on the part of the event director and organizers, the event hosting venue, event officials and volunteers, coaches, other athletes and spectators.

I, as a participant who has reached and/or is over the age of majority, freely accept and fully assume all such risks, dangers, and hazards and the possibility of personal injury, property damage, or loss resulting from such dangers, risks, and hazards. In consideration of the Shooting Federation of Canada (SFC) allowing me to take part as manager, coach, volunteer or athlete, official or spectator in this Event, I hereby agree to waive my right to legal action as follows:

1. To assume and accept all risks, dangers and hazards in connection with my participation in, and/or travel to and from the Event;
2. To waive any and all claims that I may have against the competition director or organizers, The Shooting Federation of Canada, Saskatoon Wildlife Federation, Saskatchewan Target Shooting Association, Alberta Handgun Association, and its directors, officers, employees, agents, volunteers and representatives of each of those organizations (the “Parties”) in connection with this Event;
3. To release the Parties from any and all liability for any loss, damage, injury or expense that I, or my next of kin, may suffer or incur as a result of my participation in, at, and/or travel to or from the Event, due to any cause whatsoever, including

negligence on the part of the Parties; and

4. To hold harmless and indemnify the Parties for any and all liability for property damage or personal injury suffered by myself or by a third party as a result to my participation in, at, and/or travel to or from the Event.

I will immediately remove myself from participation in the Event and notify the nearest official, if at any time I sense any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of my clothing, gear or equipment, for continued safe participation in the Event.

I will abide by the SFC Code of Conduct while attending the Event.

### Privacy Consent

I grant the Parties permission to collect, use and disclose my personal information for the following purposes and consent to the:

- communication of events, programs and information via telecommunications, post, electronic and/or social media;
- publication of participant registration and competition lists and results of the competition and the publication of same in newsletters, media releases, websites or Event information boards;
- use of my photograph, video, audio recording and or interview with no expectation of monetary compensation;
- waiver of any inspection or approval of the finished communications prior to publication;
- use of my date of birth to Event organizers and officials to determine age group in Event participation, if required;
- Event organizers or officials, to the publication of my contact information for Event related communications.
